(KAP. 458)**

Regoli ta' l-2010 dwar il-Ħinijiet li fihom Jifthu l-Ispizeriji

BIS-SAHHA tas-setgħat mogħtija bl-artikolu 89 ta' l-Att dwar il-Mediċini, l-Awtorità dwar il-Liċenzjar għamlet dawn ir-regolamenti li ġejjin:-

1. It-titolu ta' dawn ir-regolament hu Regolamenti ta' l-2010 dwar il-Ħinijiet li fihom Jifthu l-Ispizeriji. Titolu.

2. (1) L-ispizeriji f'Malta u Għawdex għandhom jifthu mill-inqas mid-9.00 a.m. sa 12.00 nofsinhar u mill-4.00 p.m. sas-7.00 p.m. mit-Tnejn sas-Sibt u jistgħu jibqgħu miftuħin għal kull żmien aktar minn dawn is-siegħat. Ftuħ ta' spizeriji matul il-ġranet tal-ġimgħa.

(2) Is-Sibt wara nofsinhar l-ispizjar responsabbli jista' ma jiftaħx l-ispizerija tiegħu sakemm ikun hemm spizerija oħra li tkun miftuħa f'dik il-lokalità kif imfissra fit-Tieni Skeda li tinsab mal-Att dwar Kunsill Lokali, u skond roster li jinħareġ mill-Awtorità dwar il-Liċenzjar. Kap. 363.

Iżda f'dawk il-lokalitajiet fejn ikun hemm biss spizerija waħda, dik l-ispizerija għandha tiġi inkluża fir-roster ta' spizeriji għal-lokalità fil-viċin skond ma tista' tiddeċiedi l-Awtorità dwar il-Liċenzjar.

(3) Ikun id-dmir ta' l-ispizjar responsabbli li ma jiftaħx l-ispizerija tiegħu s-Sibt wara nofsinhar li juri b'mod ċar fuq il-bieb tal-ispizerija tiegħu l-isem u l-indirizz tal-ispizerija li tkun miftuħa f'dik il-lokalità, kif imfissra fit-Tieni Skeda li tinsab mal-Att dwar Kunsill Lokali, u skond ir-roster li jinħareġ mill-Awtorità dwar il-Liċenzjar.

**MEDICINES ACT
(CAP. 458)**

Pharmacies (Opening Hours) Rules, 2009

IN exercise of the powers conferred by article 89 of the Medicines Act, the Licensing Authority has made the following rules:-

1. The title of these rules is the Pharmacies (Opening Hours) Rules, 2010. Title.

2. (1) Any pharmacy in Malta and Gozo shall be open from at least 9.00 a.m. till 12.00 noon and from 4.00 p.m. till 7.00 p.m. from Monday to Saturday and may remain open for any period beyond these hours. Opening of pharmacies on weekdays.

(2) On Saturday afternoon the managing pharmacist may not open his pharmacy as long as there is another pharmacy which is open in that locality as defined in the Second Schedule to the Local Councils Act and according to a roster issued by the Licensing Authority: Cap. 363.

Provided that in those localities where there is only one pharmacy, such pharmacy will be included in the roster of pharmacies for the neighbouring locality as the Licensing Authority may determine.

(3) It shall be the duty of the managing pharmacist who does not open his pharmacy on a Saturday afternoon to have clearly displayed on the door of his pharmacy the name and address of the pharmacy which is open in that locality, as defined in the Second Schedule to the Local Councils Act, and according to the roster issued by the Licensing Authority:

3. It shall be the duty of the managing pharmacist to ensure that on Sundays and public holidays his pharmacy shall at least be open from 9.00 a.m. to 12.00 noon strictly in accordance with the roster issued for the purpose by the Licensing Authority. Opening of pharmacies on Sundays and public holidays.

Provided that the provisions of this rule shall not apply for that pharmacy at the Malta International Airport.

4. The Opening Hours of Dispensaries Order, 2002 is hereby being revoked.
